
With our partners, we scope developments influential to ICSOs' relevance, and analyse fresh innovations for greater impact in these complex times.

Directors of Policy, Programme and Human Resources of ICSOs share learnings, discuss best practices and explore opportunities for joint action. The 2021 meeting will focus on organisational culture, values and leadership.

Making Voices Heard and Count | Annual Meeting

November | Virtual

To make Agenda 2030's promise to "leave no one behind" a reality, this partnership promotes active use of community-driven data in the monitoring, review and implementation of the SDGs. Partners foster participation of marginalised communities in agenda-setting dialogues with local and national decision-makers.

Solidarity Action Network (SANE) | Annual Meeting April | Virtual

The network brings together ICSOs and local partners for mutual support

when facing undue threats and challenges to operations, or other broader restrictions to civic space. It enhances cooperative mechanisms for joint action, beyond public statements of solidarity, to push back against clampdowns on civil society. In 2021, an online platform will allow collaboration and development of joint actions on a digitally secure channel.

Leading the Power Shift and Governance Reform | Annual Meeting 16-18 March | Virtual

The Power Shift Lab will continue strengthening ICSOs' impact by encouraging a more effective and legitimate distribution of powers, roles and responsibilities in their governance, specifically by strengthening the voices of the communities they serve. This year we have a greater ambition to expand our community, embrace digital participation, and explore innovative formats.

Global Standard for CSO Accountability

Global networks promote a more inclusive and responsive approach to civil society accountability. Using 12 commitments, the Global Standard promotes a shared understanding and embodies a dynamic approach to accountability by encouraging organisations to engage in a continuous two-way dialogue with stakeholders.



Who do we work with?

The term "civil society" encompasses a huge variety of organised and non-organised actors, spanning movements, activists and service deliverers, donors and philanthropists, as well as media, academia, social businesses, and others. We forge partnerships by bringing these actors together; seeking out the best innovations; and fostering mutual learning and joint action across the sector to achieve fundamental positive change in the world.

Our Owners and Supporters

The Centre is owned and supported by more than 20 of the largest international civil society organisations working across environmental, human rights, social justice and humanitarian issues.
